Previously opening permission has been accorded to the classes VI-X (EM) during the years 2015-2016 in Proceedings L.Dis.No.3413/B4/2015 Dated 27.11.2015 of the Regional Joint Director of School Education, Kakinada. The Correspondent has submitted the application for Provisional Recognition for the classes VI-X (EM) in the school for the year from 2015-2016 to 2024-2025 in the reference 5th cited. The District Educational Officer, East Godavari has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer in the reference 6th cited and as per the G.O.Ms.No.1 Education, Dated.01.01.1994. Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby accords Provisional Recognition for a period of 10 (TEN) years i.e., for the academic year from 2015-2016 to 2024-2025 for the classes VI-X (EM) without any Grant-in-Aid now are in future and subject to fulfillment of the following conditions in Lakshya High School (EM), Valluru Village, Unduru Panchayat, Samalkot (M), East Godavari District:

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Provisional Recognition sufficiently in advance i.e., At least six months prior to the date of expiry of the present recognition.
14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
15. The management informed that no thatched roof accommodation is allowed to run the School.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
20. The school shall have first aid kit and the teachers shall be trained in first aid.
21. The Correspondent of the concerned school is hereby informed to file an affidavit on or before 30th April of every year to the effect that there is no deviation or Violation of norms prescribed by the Government from time to time.
22. That the Management shall obtain and submit the structural soundness certificate and sanitary certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
23. That the Management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
24. That the Management has to maintain trained teachers at all time.
25. That the Management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
26. That the Management of the school is informed to obtain the occupancy clearance from the Fire Services department concerned for the entire period of recognition now accorded from time to time and submit the same to this office without fail.
27. That the Recognition now granted is subject to genuineness of the Fire No Objection Certificate issued by the Fire Service Department concerned.
28. That the Management of the school is informed to obtain the Structural Soundness Certificate issued by the EE, R&B/PR concerned and submit the same to this office without fail.
29. That the Management of the school is informed to submit the extension of Registered Lease Deeds of School Building & Play area for the remaining Recognition period i.e., 01.02.2025 to 31.05.2025 to this office before expiry of present lease deed without fail.

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed. Receipt of these proceedings should be acknowledged.
